- These devices should be used only where they will not interrupt the current.
- These devices have not been investigated for current-carrying capability.
- The acceptability of the grounding connection shall be determined by the end product use engineer.
- The electrical and mechanical suitability of the wiring terminals shall be determined in the end use.
- The placement of these devices within the equipment enclosure should be such that spacings between the live parts and the equipment are suitable for the particular application.
- The suitability of the spacings between adjacent poles and the associated voltage rating shall be determined in the end-use. Dielectric testing has not been performed.
- The Conductor Secureness Test for crimp contacts has not been performed.

- The suitability of the insulating materials used in the molded bodies shall be judged in the end-use equipment.
- The operating temperature of these devices should not exceed the temperature ratings of the insulating materials. These materials may be used *interchangeably at maximum temperature of 75°C.
- 10. The lead wire material which is supplied by the end manufacturer should be judged in the end-use application.
- 11. The lead wires are mechanically secured to the receptacle connector and should be judged in the end-use application.
- 12. The maximum volt-ampere rating should be judged in the end-use application.
- 13. The connector is only for use inside a compressor that employs Refrigerant Types R12, R22, R500, or R502.
