Unless otherwise specified, dimensions have a tolerance of ± 0.13 [.005] and angles have a tolerance of $\pm 2^{\circ}$. Figures and illustrations are for identification only and are not drawn to scale.

1. INTRODUCTION

This specification covers the requirements for application of the AMP* Low Profile, Economy, Dual Beam, and Multiposition Shunt Connectors. Low Profile and Economy Shunt Connectors are available in carrier strip form. The Dual Beam Shunt connectors are available in loose piece or carrier strip form. The Multiposition Shunt Connectors are available in 2 through 14 dual positions for 5.08 [.200] centerline and in 2 through 20 dual positions for 2.54 [.100] centerline.

When corresponding with AMP personnel, use the terminology provided on this specification to help facilitate your inquiry for information. Basic terms and features of components are provided in Figure 1.





3. REQUIREMENTS

2 of 4

The post requirements for the shunt connectors are identified in Figures 2 and 3. The mating post length for all connector versions must be a minimum of 5.08 [.200].

The Low Profile and Economy Shunt Connectors are designed for mating, commoning, or shorting two 0.64 [.025] square or round posts, or two 0.56 X 0.66 [.022 X .026] rectangular posts on 2.54 [.100] or 5.08 [.200] contact centerlines.





The Multi Position Shunt Connectors are designed for mating, commoning, or shorting multiples of two 0.64 [.025] square or round posts on 2.54 or 5.08 [.100 or .200] contact centerlines.

The Dual Beam Shunt Connectors are designed for mating, commoning, or shorting two 0.64 [.025] square or round posts.



4. QUALIFICATIONS

Shunt Connectors have been listed under Underwriters Laboratories Inc. (UL) File number E28476.

5. TOOLING

Connectors may be installed by hand or with needle-nose pliers until bottomed. Connectors may also be removed by hand or with needle-nose pliers. No application tooling is required.

NOTE

Care should be taken when using pliers that excessive force is not applied to sides of connector, which could cause shunt failure.






FIGURE 5. VISUAL AID
