Declaration for the Limitation of hazardous Substances

Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment

The products which are manufactured and distributed by Hirschmann Car Communication GmbH are exclusively designed for vehicle application.

According to the comments for the application range of directives 2002/95/EC 2002/96/EC resp. the successors 2011/65/EU and 2012/19/EU „FAQ on directives 2002/95/EC (RoHS) and 2002/96/EC (WEEE)“ of the European Commission, chapter 1.7, these products are not covered by the application range of these European directives.

Our products are covered by the EC directive 2000/53/EG (End-of life vehicles directive, ELV).

Thus our products have to fulfil the requirements of the EC end-of life vehicles directive in case of restricted prohibition for the use of Lead, Mercury, Chromium VI and Cadmium in addition, flame retardant products such as PBB and PBDE are covered by the EC directive 76/769/EC and it's amendments.


