

California Consumer Privacy Notice



In this notice we inform TE's consumers who are based in California about their privacy rights as protected by applicable laws such as the California Consumer Privacy Act.

TE collects the following types of information

When visiting our websites, we will collect your Internet Protocol ("IP") address as well as other information, such as browser, device type, domain, host names, pages viewed and viewing patterns, as well as the country/region where you are located.

When you place an order in the TE Store we also collect information relating to your purchase.
